

**MINTUES OF THE REGULAR MEETING OF THE BOARD OF EDUCATION  
OF THE AUGUSTA SCHOOL DISTRICT #10  
May 17, 2010**

The Augusta Board of Education met in regular session at 6:30 PM on Monday, May 17, 2010, in the administrative offices. President James Harston presided over the meeting. Members present were Debbie Briscoe, Janice Collier, Amanda Hanna and Buddy Porter. Willie Powell and Katina Briscoe were absent. Superintendent Richard Blevins was also present.

James Harston opened the meeting with a prayer.

The vote was 4-0 with Member Buddy Porter abstaining from the vote due to family connection with one of the rehires.
